## Introduction

### **Tender for Tonga Power Limited: Mowing Services**

Tonga Power Limited (TPL) invites qualified and experienced contractors from Tongatapu to submit proposals for the provision of Mowing Services across TPL properties in various locations (see Fig 2.1 for details). This tender aims to secure a reliable service provider to maintain a clean and well-kept appearance at all TPL properties.

To ensure our properties remain in excellent condition, Tonga Power Limited seeks a contractor committed to consistent, high-quality service.

The successful bidder will be responsible for:

- 1. Mowing and maintenance of grounds around all sites, including TPL's solar facilities, offices, distribution sites, power stations, data collection areas, and wind turbine locations.
- 2. Providing services at designated locations: Tofoa, Popua, Vaini, Niutoua, Nakolo, Matatoa Tofoa, and in the outer islands of Vava'u, 'Eua, and Ha'apai.

This tender document outlines service requirements, eligibility criteria, and submission guidelines for prospective contractors. Interested parties are encouraged to review it carefully and submit bids that align with all specified requirements.

#### **Requirement for Valid Bid;**

In order to be valid, a bid must:

- a) Include a duly completed BID FORM and a copy of the BID FORM.
- b) Include a duly completed BID Declaration Form and a copy of the BID DECLARATION FORM.
- c) Lodge of application in accordance to condition of Bid.

#### **Lodgement of Bids**

- a) MUST be enclosed in a sealed envelope marked "APPLICATION" addressed to CEO, Tonga Power Limited, Nukualofa, Tonga.
- b) MUST be clearly labelled "Bid for Mowing Services".

## All areas to be mowed must comply with the following;

- a) Fence Perimeter and Under Solar PV panels to be kept clean (the use of weed killer spray is acceptable although an environmentally friendly weed killer is preferred)
- b) Between every row of panels to keep it clean and mowing but not as low to kick up rock that may damage panels
- c) Access Road to the office and working area to mow and keep it clean and tidy
- d) No grass cuttings are to be left on the area
- e) Any litter that is mowed must be removed.

#### 3) Duration of the Services

• Two (2) years from commencement

#### 4) Closing Time

• The period for the receipt of bids will run until 4pm of 22<sup>nd</sup> November, 2024. (The deadline for bids submission).

#### 5) Requirement for Valid Bid;

#### 6) Lodgement of Bids

c) MUST be enclosed in a sealed envelope marked "APPLICATION" addressed to CEO, Tonga Power Limited, Nukualofa, Tonga.

d) MUST be clearly labelled "Bid for Mowing Services".

# 7) Late Bids

a) Any bid received after the Closing Date will not be considered by TPL

b) Any Bid which does not comply with the requirements in conditions of bid may be rejected.

# 8) Costs

- a) The bidder acknowledges and accepts that it bears all of its own costs and expenses in preparation of the bid.
- b) TPL is not responsible for any cost may be incurred in the preparation of bid.

# 9) Bid Conduct

Bidders must not:

- a) Engage in any form of collusive tendering.
- b) Lobby TPL's employees.
- c) Offer gifts or personal benefits to TPL's employees.

# 10) Withdrawal of Bid

• Bid cannot withdraw their tender offer prior to the expiration of sixty (60) days from the Closing Date but may do so at any time thereafter.

# 11) Acceptance of Bid

- a) Bids shall be open to acceptance by TPL for a minimum period of thirty (30) days from the closing date.
- b) TPL is not bound to accept any tender, including the lowest tender.
- c) TPL reserves the right, in its absolute discretion, engage a bidder to perform only some of the services set out in clause.
- d) Once a bid is accepted by TPL in accordance with Bid documents together with the written acceptance of the bid constitute a legally binding agreement between TPL and the successful bidder and the successful bidder agrees to so bound.
- e) Sub-contracting of this service is prohibited
- f) Successful bidder will liable to all costs such as damages, injuries or public liability insurance.

# 12) Evaluation Criteria

- All Bids will assess based on the following criteria;
  - a) The resources of the bidder including technical, managerial, physical and

financial resources;

- b) The proposed methodology
- c) Understanding of the task
- d) The price, which represents the best value for money
- e) Bidder past experience and performance history including: time management, standard of work, the time for completion and quality assurance.
- f) Inspection of Equipment

### **13) Further Information**

- TPL, in its absolute discretion, may require the bidder to demonstrate the rationale for how prices are set including, but not limited to:
  - a) Requesting the bidder to provide documents in support; and
  - b) Inviting the bidder to discuss with how the prices have been built up.
